### 4. Review of November 19, 2017 Minutes

## 5. <u>Commissioner Report</u>

Presented by Shawn McCarty- Commissioner

- We held Southwest Boys Tours event in conjunction with Redlands. We had 25 boys team from several states attend. We had good reports about the Bennett Center at the Oklahoma City Fairgrounds.
- We have visited several tournaments this season. There have been no major issues at the events.
- The AES tournament system is working very well. The "one-shop shopping" is very efficient. We have been working with AES to fix some minor bugs but for the most part, the system is running smooth. One of the best functions of the AES system is it allows us to see how many teams are registered for tournaments in live time. As we get additional tournament requests it is very helpful to have access to this information. Also, tournament directors are doing a good job getting their results entered into AES. This provides us with up to date rankings.
- There is talk of a mid-season RVA meeting in Chicago in March. The meeting is not confirmed at this time.
- We met with the OKC Convention and Visitors Bureau about moving our Regional Championships to OKC in 2019. They will serve as a conduit with the OKC Fairgrounds Trust. I

also met with Larry Taylor of Charge to discuss his experiences with Redlands. Further meetings and debriefing will take place in the next few weeks.

- The 18's bid qualifier will take place at Westmoore HS on Sunday, February 25, 2018. We have 12 teams. I don't anticipate any further entries. We will award our National and American bids to GJNC in Anaheim.
- The 14's/15's/16's rankings tournament will take place on Saturday, February 24, 2018 at the Premier Sportsplex. We will have 12 teams in the 14's and 15's Divisions and 8 teams in the 16's Division.
- Registrations are coming in for Regionals. It is too early to tell where we will be on total number of teams but since our membership is up almost 200 members, we would anticipate a small increase in the number of teams.

#### 6. Registrar Report

Presented by Libby McCarty.

- As of February 10, 2018, we have 3,784 members. This is almost 200 members higher than this time last year.
- We have been working with several new clubs to acclimate them to the Web point system and other region paperwork.
- We have issued approximately 8 refunds this season.

#### 7. Treasurer Report

## 8. <u>Junior/SafeSport Reports</u>

### 9. Beach Report

Presented by Shawn McCarty.

- We have been allocated 3 bids in each age division for girls (12 total) and 6 bids for boys to the 2018 USA National Beach Tour Championships. We do not have to accept the bids, but I would recommend we do.
- In order to accept the bids, we would need to have a Beach Regionals. Lee Chartier, who is a member of the OKRVA Beach Committee, has agreed to reach out to the Lighthouse about the possibility of using their courts for the event.
- Registration for the event will be taken care of by USAV Beach Office.
- Beach Nationals is July 19-21<sup>st</sup> for U12 and U16 and July 22-24<sup>th</sup> for U14 and U18. The Beach Championships will be held in Siesta Key, Florida.
- OKRVA has sent kids to Beach Nationals for several years by qualifying in other regions.

#### HP Update

- The HP Championships will be held in Tulsa on July 24-28, 2018. We have our offered our support to USAV and the AJ Joseph the tournament director.
- HP Tryouts will be held on Friday, May 4<sup>th</sup>. We have stared recruiting some players to tryout. We will send marketing materials to athletes and club directors and coaches by February 18<sup>th</sup>.
- We have budgeted for 4 teams. We are currently scheduled to send two Youth and two Select teams. We need to discuss the possibility of adding one Future Select Girls team and possibly removing one Youth team.

• Jeremy Burton made motion to give executive committee authority to approve funding for another HP team this season. Second by Nikki Dieball.
