- **Club Teams** – You may request late application for entry. A Club team must meet the following guidelines to apply for consideration after the **June 5rd** deadline:

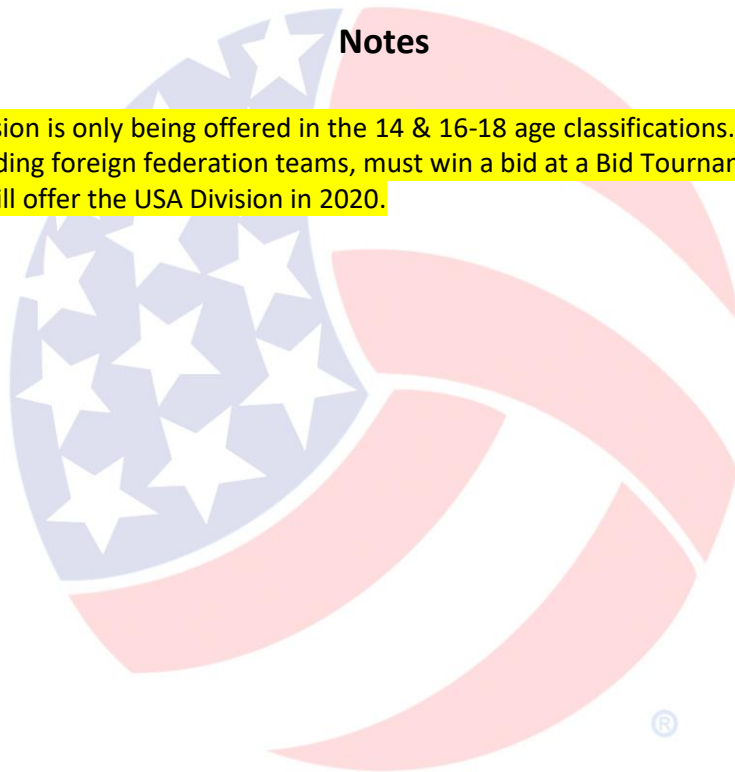
1. Confirm and provide proof (e.g. letter or email) of Region approval
 2. Contact the Events Department to request consideration and be waitlisted.
- **Applications WILL NOT be accepted if court space and field sizes are filled. There are NO GUARANTEES that a team entry will be accepted after the June 5th deadline. Therefore, enter early!**
 - **If your Region deems the club or team not in good standing, your late entry application will NOT be considered.**
