As of February 19, 2021, we have 4,474 members. This is up from 3,466 reported at the November 8, 2020 meeting and also up from the overall 2019-2020 season. This is at least the 17th continuous year with an increase in memberships. The new membership system, SportsEngine has proved to be a difficult transition. We are working with USAV and SportsEngine to navigate issues as they arise. We had three individuals fail their background screening. Two of these were reprocessed and approved. The third is ineligible at this time. We do not know the reason why they are ineligible. Upon direction of Executive Committee, two players were transferred in January 2021.
