Junior Clinics for Scorers and R2s were held at Union Freshmen Academy on Friday, December 8 and at Classen Center on Tuesday, December 19. Neither clinic had a great turnout. The clinics need to be planned earlier; I will work on that for next season.

Official Rating Clinics were held on December 16 at Stillwater Cowboy Ratings Tournament and at Nienhuis in Broken Arrow. A small rating session was held at Titan on January 3.

The Officials Committee approved the application for Regional Certification at OKRVA Rankings Tournament for two officials – Rachel McDaniel and Dani Newsom.

Michael Goodall has notified the Committee that he plans to apply for National Referee Certification. The Region is not directly involved in the acceptance process; it is handled by USAV with structured requirements.

Many new OKRVA officials have been officiating at several tournaments in the Region. I evaluated several officials at the Midwest Open on Saturday, February 3, 2024.

The Committee met on Google Meets to discuss two situations that have been reported in the Region, both occurred at Adidas Classic.

- 1. Corey Harp sent an email about the assignment of officials for the Adidas Tournament. Toni Slagle also sent an email about the incident. An email was sent to the parties involved: Corey Harp, Missy Frette and Toni Slagle. (I will include a copy of the email response with this report.)
- 2. The other situation was an Official using profane language. This situation was reported by Toni Slagle, the head official, and by Lee Johnson, the assistant coach. I will research the USAV Training courses that are available and appropriate to recommend to the official. The Committee will discuss this again when I find appropriate Training Course.

This discussion brought up questions of the purpose and authority of the Officials Committee.

- 1. Is the Officials Committee a "clearing house" to investigate complaints/incidents about officials and bring the results to the attention of the Board?
- 2. Should the Officials Committee act on complaints/incidents that are reported to the OKRVA Commissioner and then reported to the Officials Committee?
- 3. If the Officials Committee is to act on complaints/incidents, do the OKRVA By Laws need to be updated?
