# **Regionals Recap**

- We ended up with 341 teams. This is up from last year and shows 20+ consecutive years of new record attendance.
- There were several challenges to overcome but nothing major.
- We met with Tulsa County Commissioner, Stan Sallee and Mark Andrus, CEO of Tulsa County Public Facilities Authority. Both expressed a desire for us to bring the event back in 2025
- We received a lot of positive feedback from parents, officials, coaches and club directors. Highlights include:

# Beach Report

# Shawn McCarty

14 clubs registered for USAV/OKRVA programming for 2024 (up from 12 active groups last year). All known clubs in Tulsa are operating with either OKRVA sanction or dual-sanction w/OKRVA included. OKC still has some AAU-only operations.

2024 tournaments to-date seeing increase in

- total # of team entries
- # of out-of-region entries (encouraging sign, means tournaments are being run well enough to draw other regions)

USAV now using a new application for tournament management. A few minor challenges as tournament directors using it for the first season are accustomed to it, but no significant problems so far.

- Beach Regionals tentatively scheduled for June 28-30. Concerns on the condition of Helmerich Park in Tulsa. If the facility can get needed improvements, Regionals may be 3-day event. Sarah Kling from Blue Beach will be 2024 tournament director.
- New indoor/outdoor beach facility scheduled to open in NE OKC in 2025.

Officials Committee Report Jeff Boyland There were approximately 15 new officials that completed the online training and officiated in 2024 season.

Both Regional candidates (Dani Newsom and Rachel McDaniel) were promoted at the Rankings Tournament.

The Officials Committee will meet before the 2024-2025 season begins so that we can plan how to train officials in person in an actual volleyball set. This scenario would provide the ability to demonstrate to officials, situations as they actually happen

Junior/Rankings Committee ReportsJody WebberJody submitted rankings results for OKRVA Regionals to OKRVA BOD (see Exhibit A). Jody gave briefexplanation of AES Power Rankings are all matches, USAV rankings are only USAV matches. Goodlessons learned with rankings committee reviewing all ages this season.

Discussion of teams invited to Ranking's tournament and not attending this tournament. It does not give the rankings committee additional important information. Also, discussion of possible other ranking systems to assist in rankings for tournaments.

OKRVA Rankings Procedure document published on OKRVA website.

OKRVA Rankings Procedure recommendations:

51: 30 In ranking teams for Regional, priority should be given based upon:

- 1. Head- to- head results (most recent victory would weigh more heavily)
- 2. OKRVA Rankings Tournament results
- 3. Common Opponent results
- 4. Secondary Information that could be used to break ties
  - a. Finishes at qualifiers if teams are in the same qualifier. However, this should only be consideration if finishes are significantly different. (Example: if two teams finished 4-5 spots different but did not play each other and had no common opponents, this should not be a large factor. However, if one team finishes 5<sup>th</sup> and the other 45<sup>th</sup>, more weight should be given
- 5. Other factors to accurately rank:
  - a. Find the top four or five teams and compare their records against each other. For instance, what is team 1's record against the 2-5.
  - b. Establish a second person to review the rankings of the top 4-5 teams, as no team, below a four seed, has ever won regionals.

Discussion was to possibly host 18s Bid Qualifier and Rankings tournament on the same weekend. Discussions as to why Ranking's tournament is important.

Motion by Shawn McCarty second by Janet Tyler to allow Shawn negotiate with OKC Fairgrounds for Rankings tournament, 18s Bid Qualifier and OKRVA Rankings to be held around same weekend as current season 2023-2024 for next 2024-2025 season. All approved.

<u>Setting of tryout dates for 2024-2025 Season</u>. Randy Decker The proposed dates for all ages for the 2024-2025 season are below:

11s - 12s – Tryouts can **begin no earlier than Tuesday September 24, 2024** – signing date begins no earlier than Saturday, October 5, 2024

13s - 14s - Tryouts can **begin no earlier than Tuesday October 8, 2024** – signing date begins no earlier than Saturday, October 19, 2024

15s - 18s - Tryouts can **begin no earlier than Tuesday October 29, 2024** – signing date begins no earlier than Thursday, November 9, 2024 Motion made by Shawn McCarty second by Margo Juergens, discussion for and against, 3 yes 4 no, motion did not pass. 15s - 18s - Tryouts can **begin no earlier than Monday October 28, 2024** – signing date begins no earlier than Thursday, November 7, 2024

**Statement Regarding Pressuring of Players** – The region continues to hear concerns from players/parents about feeling pressured by coaches/clubs to sign by a certain date/time. Below is a series of statements that could be inserted into region and club documents to make clear the region's philosophy on this issue:

It is the intent of the Oklahoma Region to encourage players to try out for as many clubs as they choose.

It is the regions intent that players not be pressured into a verbal commitment due to a coach/club establishing an unreasonable date/time for a decision

A decision to join a team/club is individual decision that should be made by a parent/player alone from club pressure. Gathering players together after a tryout, stating "this is their team" and asking for commitments should be considered pressuring

When a player receives an offer to sign, she/he needs to make a decision within a reasonable amount of time. Delaying a decision affects many other players who are also waiting for an offer to commit.

Players/Parents should understand that teams/clubs need to know a player's decision in a timely manner in order to move on to the next player.

No player/parent should be asked to sign a contract before the region approved signing dates. Contracts are not binding until the signing date.

If a player feels pressured into a decision before, they have gone to other club's tryouts, she/he should contact the Region Commissioner at ...
